- Registration will begin promptly at 9 a.m., with the actual pageant start time of 10:30 a.m.
- There are five age groups (age determined by the date of the pageant).
- The entry fee is \$45 is non-refundable and should be made payable to CCFA. If you wish to pay via credit card, there is a 3% service fee, you must contact the director to receive that invoice.
- This application must be typewritten (fillable online, either print and mail or save and email to the director. The application is not considered complete until **all** fees are received. There is a \$35 charge for any NSF received.
- Contestants will be provided with a black pageant t-shirt to wear during their opening parade. Please wear your own denim/navy shorts, skirt, etc.
- This is NOT a toddlers/tiaras type of pageant. Contestants are encouraged to show off their natural beauty, smile, confidence, poise and stage presence.
- Competition will be in Personality wear (a fun wear - something that they enjoy and makes them smile) and also a Formal wear (a dress up/evening gown outfit). Teens will also be asked a (simple) onstage question.

All correspondence will be done via email, so please make sure that you are checking your email on a regular basis.

Today's winners will become a part of the "Chesterfield Royals" and will be expected to stay for the Queen pageant, following this pageant. The Chesterfield County Fair will be held Aug. 22-30, 2025 at the Chesterfield County Fairgrounds. Royals are expected to attend the fair daily (unless special circumstances arise), as well as other events, such as Trunk or Treat, the fair's annual membership meeting, etc. They are encouraged to wear their crown and sash when attending other special events to be an ambassador for the fair.

This is our first year at a new venue **and** at a new date for the pageants. Our goal is for the Royals to be already "coronated" and ready for the fair from opening day to closing day!

## Rules And Regulations

- Contestants must be born female
- Contestants must be a Virginia resident and a U.S. citizen
- Contestants must be between the ages of 3 and 16 at the day of the pageant
- Contestants must be single and never have been married
- Contestants must never have performed any act or engaged in any activity or employment that is or could reasonably be characterized as dishonest, immoral or indecent. This includes but not limited to Facebook, Twitter (X), Snapchat, Instagram and any/all web pages/other electronic means.
- Contestants must be of good moral character and never have been pregnant and are not now pregnant nor the adoptive parent of any child.
- Contestants, other than minor or petty offenses, must never have been convicted of any criminal offense and there are no criminal charges presently pending.
- Contestants must be in good health and can participate fully and without limitation in any program/pageant activities, including but not limited to interviews, rehearsal and actual pageant event.
- Contestants must not use or consume any illegal controlled (including recreational), dangerous substances, including alcohol, tobacco, vaping or other such.
- Contestants must submit a completed application, signed waiver and entry fee to be received no later than June 30, 2025.
- Contestants are expected to be at the Chesterfield County Parks and Recreation Center on the day of the pageant between 8:45 - 9 a.m. Winners will be expected to stay/return for the Queen pageant that same afternoon.
- Contestants will be judged on confidence, smile, stage presence, poise, personality and overall impression. \*Teens will be asked a (simple) onstage question. Overall natural beauty is encouraged.
- There will be an opening “parade” (they will wear their black pageant t-shirt and denim shorts/skorts, a personality wear segment and a Formal (dress up) segment. Props are allowed.

All winners will be expected to participate in such event as parades, grand openings, holiday events, school events, etc. at the discretion of the Pageant Director. Mandatory attendance at the fair's annual Membership Meeting in November!

The entry fee for this pageant is \$45 (non-refundable). Any application received without the \$45 entry fee, the signed application, signed waiver & a recent 5x7 \*(child's name/phone number on the back - **do not fold photo!**), will not be considered until all materials have been received. \*Please note that all contestants are to submit *this* photo. Those wishing to participate in the Photogenic competition must submit a **separate** 5x7 photo of their choice (name/phone number on the back). We encourage you to put the photo(s) in individual plastic sleeves for protection. Competition photos will be returned. If you wish to have the application photo returned, please make a note on the back of the photo and see the volunteer at the conclusion of the pageant.
