Rules and Regulations

1. **Early Registration must be postmarked by Sept. 26 or emailed and paid by Sept. 30 to receive discounted fee.**
2. All equine participants must sign waiver in order to participate.
3. Current Coggins required to show (emailed or shown the day of show).
4. One entry form per horse/rider combination.
5. Classes are separated by age divisions.
 - a. PeeWee-9 and under (Adult helper allowed in the ring with rider to give assistance if needed)
 - b. Youth-17-10 years old
 - c. Adult-18 and over
6. **High point awards** will be given during October show for each division.
7. No horse can enter the same class division more than once.
8. Each horse/rider combination will be given a number the day of the show.
9. Protective headgear must be worn by all riders under the age of 18 while on horseback. Headgear is encouraged for all adult riders.
10. Judge's decision final. Less than 3 entries – divisions will be combined or canceled.
11. Adding/Scratching a class must be made 2 classes prior to that class.
12. Horses must stay in the arena area and are not allowed in the main fair area of the fairgrounds.
13. No fast riding outside of ring. Nothing above a trot. No double riding.
14. A 2-minute gate call will be allowed before rider is disqualified and a 5-minute tack change will be allowed if requested before class starts.
15. 5 second penalty added to time for each barrel or pole knocked over.
16. Participants are required to throw trash and manure in proper receptacles.
17. Entry fees must be paid in advance in order to be included in classes.
18. Make checks payable to CCFA (Chesterfield County Fair Association).

Entry Fees: \$8 per class or \$72 unlimited classes (per rider/horse combination).

Early registration fees: \$7 per class or \$66 unlimited

I, the rider or guardian of minor (under 18), enter the above horse at my own risk. I have read the above Rules and Regulations and agree to them. I agree if any injury or death occurs to the animal exhibited, myself or minor exhibitor, spectators or damage to any personal property on the grounds, that I hereby waive and release any claim to liability whatsoever from Chesterfield County Fair Association, all committees, property owners, sponsors, employees, members and volunteers whether the injury, death, or damage be caused by gross negligence or simple negligence of Chesterfield County Fair Association and/or Chesterfield County.
