Welcome to the 2026 Miss Chesterfield County Fair Princess Pageant. This is our 115th Fair and we're delighted to have you join us. The winners will become a part of the "Chesterfield Royals," along with our newly crowned Queen. The Chesterfield County Fair will be held Aug. 28 – Sept. 5, 2026.

Royals are expected to attend the fair daily (unless special circumstances arise), as well as other events that the Fair may be participating in throughout the year. The Fair holds its annual membership meeting in November, where all Royals are expected to attend; to be introduced to the members. All Royals are encouraged to notify the director to participate in outside activities while wearing their crown and sash as an ambassador for the Chesterfield County Fair.

- The application must be typewritten (fillable online). Either print and mail to the Director or email to the Director. The application is not considered complete until all fees are received. All communication will be done via email; it is imperative that you check your email daily to receive all updates. Except for a rare emergency, phone calls will not be made to contestants.
- Please make sure that all parents/guardians have read the rules and regulations page included with this packet and have explained them to the contestant.
- Princess contestants will be given a navy t-shirt and are to wear white capris or shorts and white tennis shoes.
- Teen contestants will participate in interviews (new!). Preteens and Teens will be asked an on-stage question by the judges (new!).
- Registration will begin promptly at 9 a.m. The entry fee is \$50 (non-refundable), made payable to CCFA. A \$50 fee will be charged for all NSF. If you wish to pay via credit card, please email the Director for instructions (3% service fee charged).

Optional - Photogenic contest. If you wish to enter, there is a \$5 per photo fee. All photos must be either 5x7 or 8x10 (make sure they are secure in mailing so as not to get bent or folded). All photos must have the contestants' name and phone number on the back.

This is **not** a glitz pageant for Princesses. Contestants are encouraged to show off their natural beauty, smile, confidence, poise and stage presence. Parents are encouraged to assist their daughter(s) in practicing prior to the pageant. The judges will award a "Spirit of Chesterfield" title to the girl who demonstrates the best overall "spirit and enthusiasm."

*Note: While not a part of the Royals, this is a very honorable award!

Rules and Regulations

- Contestants must be born female
- Contestants must be a Virginia resident and a U.S. citizen
- Contestants must be single and never have been married
- Contestants must never have performed any act or engaged in any activity or employment that is or could reasonably be characterized as dishonest, immoral or indecent. This includes but not limited to Facebook, Twitter (X), Snapchat, Instagram and any/all web pages/other electronic means.
- Contestants must be of good moral character and never have been pregnant and are not now pregnant nor the adoptive parent of any child.
- Contestants, other than minor or petty offenses, must never have been convicted of any criminal offense and there are no criminal charges presently pending.
- Contestants must be in good health and can participate fully and without limitation in any program/pageant activities, including but not limited to interviews, rehearsal and actual pageant event.
- Contestants must not use or consume any illegal controlled (including recreational), dangerous substances or abuse the use of alcohol, tobacco, or other dangerous substances. This includes any/all legal drugs as well.
- Contestants must submit a completed application, signed waiver and entry fee to be received no later than June 30, 2026.
- Teen contestants will meet for private interview(s) with pageant judges prior to the competition. Teen and Preteens will answer an onstage question as well.
- Contestants will be judged and graded on private interview (Teen), personality wear, evening wear, on-stage question (Teen and Preteen), poise, confidence, smile, enthusiasm and overall presentation.
- All Princesses will also be **expected** to participate in such events as the fair's annual membership meeting, parades, grand openings, holiday events, school events, etc. at the discretion of the Pageant Director.

The non-refundable entry fee of this pageant is \$50. Any applications received without the entry fee, signed application, signed waiver, and a recent 5x7 color photo (do not fold or bend) will not be considered until all materials have been received.

Those wishing to participate in the photogenic competition must submit a **separate** 5x7 or 8x10 photo of their choice (name and phone number on the back of each). Competition photos will be returned. If you wish for the application photo to be returned, please make a note on the back of the photo and see the volunteer at the conclusion of the pageant.
