#### **RULES AND REGULATIONS**

- ❖ Contestants must be born female
- ❖ Contestants must be a U.S. citizen
- ❖ Contestants must be between the ages of 3 and 16 at the crowning of title(s)
- ❖ Contestants must be single and never have been married
- ❖ Contestants must have never performed any act or engaged in any activity or employment that is or could reasonably be characterized as dishonest, immoral or indecent. This includes Facebook, Twitter, Snapchat, Instagram and any/all web pages or any other electronic means.
- ❖ Contestants must be of good moral character and never have been pregnant and are not now pregnant nor the adoptive parent of any child. A contestant, other than minor or petty offenses, must never have been convicted of any criminal offense and there are no criminal charges presently pending against her.
- ❖ Contestants must be in good health and can participate fully and without limitation in any program/pageant activities, including but not limited to interviews, rehearsal and actual pageant event.
- ❖ Contestants must not use or consumer any illegal controlled, dangerous substances or abuse the use of alcohol, tobacco or other dangerous substances.
- ❖ Contestants must submit a completed application, waiver and entry fee – and postmarked no later than **August 7, 2020.**
- ❖ Contestants will be expected to be at L.C. Bird High School on the day of the pageant at 8:30 a.m. & winners will be expected to be present at the fair that same afternoon, also at the Queen pageant, held on Monday, Aug. 31 at 8 p.m.
- ❖ Contestants will be judged on the following: confidence, smile, stage presence, poise, personality and overall impression. This is NOT a toddlers/tiaras-type of pageant. Over-all natural beauty is highly encouraged. There will be an opening segment, a “fun-fashion” wear segment and a “dress-up/evening wear” segment. Props are allowed.
- ❖ The winners in each age group will be expected to participate in such events as parades, grand openings, holiday events, school events, etc. at the discretion of the Pageant Director.
