### Show Schedule

### Open Junior Show Rules and Regulations

1. All entries, exhibitors, and visitors are subject to these rules and regulations.
2. The show is Open to all entries of Standard and recognized non-standard varieties of Large Fowl, Waterfowl, and Bantams. **Exhibitors may not enter more than two entries of the same age and breed class.**
3. The Entry form for a youth must specify exhibitor's age at the time of the show, and indicate if they will participate in Showmanship. Showmanship will start at 10 a.m.
4. Showmanship is open for ages 5 to 18 years of age.
5. Show entry fee is \$6 per bird. Entries of single birds only. Double cooping is not available.
6. Pre-registration with confirmed payment on file is required to enter the fairgrounds. **We must receive payment of \$6 per bird entered to secure your spot.**
7. One Admission ticket is included in paid, pre-registration for each child and 1 parent. Additional tickets are available for purchase online or at the gate.
8. **All registrations & monies must be postmarked no later than Aug. 19, 2024. Emailed registrations must be sent and paid by Aug. 21, 2024,** to secure your spot. Payment via check or credit card will be accepted. There will be a \$35 NSF charged for any/all returned checks or credit card transactions. **No refunds will be issued.**

There will be an added 3% processing fee charged.
9. Space is limited and will be first come first serve. Make checks payable to CCFA (Chesterfield County Fair Association). **All payments returned for insufficient funds are subject to a \$35 NSF charge.**
10. **No Late Entries will be accepted!**
11. All poultry should enter the Fairgrounds through **Gate 4**, by 10 a.m. Aug. 31. Poultry will be judged on the same day.





## Rules and Regulations cont.



12. Birds are entered at the sole risk of owner. Chesterfield County Fair Association, all committees, property owners, sponsors, employees, members and volunteers will not be held responsible for the loss or accident to any birds or persons. Birds are to be handled only by the Owner, Judge or CCFA Show officials.
13. **All birds** for exhibition in Virginia shall originate from U.S. Pullorum-Typhoid Clean Flocks or have a negative Pullorum-Typhoid Test within 90 days, (30 days for out of state birds), on the day of exhibition. A copy of the Pullorum-Typhoid test or NPIP Certification must accompany birds at check in. Birds without test papers will be tested before they can coop-in
14. Sick stock will not be allowed to be cooped-in and must be removed from Fairgrounds.
15. Any stock found to have lice, mites, or otherwise unwell will be removed by the owner, if present, or by the Show Official if the owner is not present.
16. Judging will be done according to the APA and ABA Standards of Perfection. The judge's decisions are final. The Fair is looking for quality entries. If the judge determines the entry is not worthy, they may refuse to award placings whether there is competition or not.
17. Aisles will be **closed** during judging. Only Judge, Clerk, and Show official will be allowed in these areas.
18. Exhibitors must be present to receive any awards they may win.
19. 4-H will provide feed and water for all poultry. Exhibitors are expected to feed and water their own birds with provided feed or their own. Exhibitors are expected to assist in keeping the poultry area clean.
20. Poultry will remain in place until coop-out at 5 p.m. Poultry tent closes at 10 p.m. **All** poultry must be picked up by Aug. 31 at **10 p.m.** Any poultry or property left after 10 p.m. will become property of CCFA.
21. Exhibitors are not to display "For Sale" signs on the cages. You may display your name or farm information after judging is complete.
22. Sportsmanlike conduct is expected of all exhibitors and parents/guardians of exhibitors. Any attempt to influence or intimidate a judge or any attempt to deceive and obtain an award by misrepresentation shall result in the exhibitor being excluded from competition at the Chesterfield County Fair Association Poultry Shows. The exhibitor will be asked by the Show Official to leave the fairgrounds, awards, ribbons and remove all exhibits.
23. In the event the show gets canceled due to severe weather or the State Vet Office bans Poultry Exhibitions due to Avian Influenza after entry deadline, entry fees will rollover to the 2025 show.
