Bird High School at 9:00 a.m. Contestants will need to be there at 7:45 a.m. **promptly!!** There will be five age groups, with a winner in each group. The fee to enter is \$45.00 (**nonrefundable, made payable to CCFA**) and should be included with the completed application/waiver. Contestants will be provided with a t-shirt to wear during the opening segment. They will compete in a “fun-wear” (an outfit that makes them smile; props are welcomed) category and a “dress-up/evening wear” category.

This application **must** be typewritten. You may do so online & then mail it to the address below. Please note: This is **not** a toddlers/tiaras-type pageant. Contestants are encouraged to show off their natural beauty, smile, confidence, poise and stage presence!

All correspondence will be done via **email**, so please make sure that you check your email on a regular basis.

Winners in each age group will also be expected to attend the Miss Chesterfield County Fair Pageant on Monday, August 26 at 8 p.m. There will, on occasion, be other events throughout the year that winners will be **expected** to attend (General membership meeting on November 12).

Rules And Regulations

- ❖ Contestants must be born female.
- ❖ Contestants must be a U.S. citizen.
- ❖ Contestants must be between the ages of 3 and 16 at the crowning of title(s).
- ❖ Contestants must be single and never have been married.
- ❖ Contestants must have never performed any act or engaged in any activity or employment that is or could reasonably be characterized as dishonest, immoral, or indecent. This includes Facebook, Twitter, Snapchat, Instagram and any/all web pages or any other electronic means.
- ❖ Contestants must be of good moral character and never have been pregnant and are not now pregnant nor the adoptive parent of any child. A contestant, other than minor or petty offenses, must never have been convicted of any criminal offense and there are no criminal charges presently pending against her.
- ❖ Contestants must be in good health and can participate fully and without limitation in any program/pageant activities, including but not limited to interviews, rehearsal and actual pageant event.
- ❖ Contestants must not use or consume any illegal controlled, dangerous substances or abuse the use of alcohol, tobacco, vaping or other dangerous substances.
- ❖ Contestants must submit a completed application, waiver and entry fee – and postmarked no later than **Aug. 2, 2024.**
- ❖ Contestants will be expected to be at L.C. Bird High School on the day of the pageant at 7:45 a.m. & winners will be expected to be present at the fair that same afternoon and also at the Queen pageant, held on **Monday, Aug. 26 at 8 p.m.**
- ❖ Contestants will be judged on confidence, smile, stage presence, poise, personality and overall impression. This is **not** a toddlers/tiaras-type of pageant. Over-all natural beauty is highly encouraged. There will be an opening segment, a “fun-fashion” wear segment and a “dress-up/evening wear” segment. Props are allowed.
- ❖ The winners in each age group will be expected to participate in such events as parades, grand openings, holiday events, school events, etc. at the discretion of the Pageant Director. Mandatory participation is at the November fair membership meeting.

**The entry fee for this pageant is \$45 and is non-refundable. Any application received without the \$45 entry fee, the signed application, waiver form & the recent 5x7 color photo (must have name and phone number on the reverse side) will not be considered until all materials have been received.

***Please note that all contestants are to submit this photo.** Those wishing to participate in the Photogenic competition must submit a separate 5x7 or 8x10 photo of their choice, with the name of the contestant and phone number on the reverse side. We encourage you to put the photo(s) in individual plastic sleeves for protection. Competition photos will be returned. If you wish to have your application photo returned, please make a note on the back of the photo.
